The product after preparation according to instruction: Color: Yellowish.; Taste: Characteristic, after popping in the microwave – pleasantly salty, with a noticeable butter flavor.; Flavor: Characteristic of freshly popped microwave popcorn, free from any rancid notes, with a distinct buttery flavor.; Appearance: Well-popped kernels, relatively uniform in size, with the typical uneven surface of popcorn.		Preparation instructions: Remove the plastic wrap. Place the unfolded bag in the center of the microwave with the side marked "this side up" facing up. Set the microwave to full power. Preparation time is between 2-4 minutes. Approximate preparation time 800W 2-3 min., 600W 3-4 min. Do not leave the microwave oven unattended during preparation. Listen carefully and when the crack interval is longer than 1-2 seconds, switch off the microwave. Attention the product is hot. Pull the opposite corners of the pouch diagonally to open it. Keep it away from your face and be careful of the steam coming out of the bag. Some kernels may remain uncracked.
