■ Selling Points of the production process

MUHAK's production plant is equipped with facilities that can produce up to 2,304,000 products a day. We have established a stable supply system.

We also introduced EBI (Electronic Empty Bottle Inspection) and FBI (Finished Product Inspection). We suppress the occurrence of defective products at each stage of the manufacturing process. Furthermore, by performing visual inspection by a person in addition to mechanical inspection, We reconfirm the quality and maintain a higher quality level.

In addition, our factory has HACCP certification, from acceptance of raw materials to manufacture and shipment to ultimately consumers' mouths. All processes systematically manage possible hazards.

In this way, MUHAK combines mass production capacity with a strict quality control system. We continue to provide safe and secure products to domestic and overseas markets.
